TRAFFIC BOX WRAP 2016/2017 CALL FOR ENTRY - OPEN COMPETITION

APPLICATION GUIDELINES

City Council passed a resolution in November 2013 establishing a Graffiti Task Force, made up of City staff and community partners, to combat nuisance tagging throughout the community. In an effort to fulfill this mandate and promote street art, the City has established a Traffic Box Wrap Competition that will engage local artists to beautify the boulevards of Sault Ste. Marie.

The Corporation of the City of Sault Ste. Marie is announcing the second round of open competition for local artists to submit designs for traffic box wraps. This Call For Entry is open to all artists working in a broad range of media, including painters, photographers, collage artists, mosaic artists, graffiti artists, etc. who are residents of Sault Ste. Marie and surrounding area. **This year's theme will be Canada's 150**th **Anniversary** (where focus can include but is not limited to: diversity & inclusion, reconciliation, the environment and youth).

INFORMATION ON TRAFFIC BOXES

- Traffic boxes range in size and shape and often have special features, including meters, vents, handles, etc. Please see **Appendix A** for details on the two most common traffic boxes found in Sault Ste. Marie. The Successful Design(s) as determined by the process set out herein shall be capable of being applied as a wrap to the variety of traffic boxes in Sault Ste. Marie;
- 2. This project's primary focus is the wrapping of traffic boxes owned by the City of Sault Ste. Marie in the downtown core (see **Appendix B** for proposed locations, please note these locations may change), but boxes owned by other entities may be wrapped as well with their permission;
- The Successful Design(s) may be modified to cover more than one box when they appear in a cluster and/or modified as necessary to apply to each traffic box given the variety of traffic boxes in Sault Ste. Marie;
- 4. The City of Sault Ste. Marie will digitally apply the Successful Design(s) to a high-quality vinyl wrap that will be applied to the traffic box. The Successful Artist(s) will not fabricate or install the Successful Design(s) on the traffic box; and
- 5. The City of Sault Ste. Marie shall reserve its right to determine the number and location of traffic boxes in the City of Sault Ste. Marie to be wrapped for this project.

STANDARDS FOR DESIGN SUBMISSIONS

- 1. All Design Submissions must be original, which is designed and executed by the Artist(s) submitting the design ("Submitting Artist");
- 2. Any Design Submissions made from a commercial pattern, mold, or created by anyone other than the Submitting Artist is not eligible. No copyrighted material other than that of the Submitting Artist will be accepted for entry into the competition;
- 3. Design Submissions made from purchased kits, or the use of decals, will not be accepted for entry into the competition;
- 4. Design Submissions containing commercial reproductions or embellished commercial products will not be accepted for entry into the competition;
- 5. Design Submissions shall not contain any advertising, branding or commercial images, failing which the Design Submission shall not be accepted for entry into the competition;
- 6. Design Submissions shall not be profane, indecent, obscene, or promote violence, hatred, contempt or discrimination, the determination of which will be made by the Selection Committee at their sole discretion;
- Design Submissions that cause driver distraction or that cause confusion with the traffic signs will
 not be accepted (i.e. submissions shall not contain any representations of traffic lights, signs or
 signals) for entry into the competition;
- 8. Designs Submissions must meet a high standard of quality to be considered by the Selection Committee; and
- 9. Designs Submissions should be scalable to a variety of box sizes and styles, and some cropping may occur.

ENTRY PROCESS

A Submitting Artist may submit up to three (3) Design Submissions as digital images. Each Design Submission must be a separate file that is clearly named with the title of the piece. Each Design Submission should be of sufficient high quality – 3000 pixels set at a quality of 300 dpi or better - that will allow the Selection Committee to soundly assess and review the works. Each Design Submission must be submitted on a Flash Drive or CD/DVD in a JPEG format. The submission of a Design Submission constitutes the Submitting Artist's acceptance of all competition rules and standards. The Successful Artist(s) will receive a total honorarium of \$500 to cover fees and supplies for each Successful Design. All Design Submissions must be hand delivered to the Engineering Division of The Corporation of the City of Sault Ste. Marie, 5th Floor, Civic Centre, 99 Foster Drive, in a sealed envelope no later than 4:00 p.m., on Friday, January 13, 2017. All other Design Submissions not meeting the qualifications set out herein shall be disqualified.

SELECTION PROCESS

In an effort for the Selection Committee to remain objective and unbiased during the selection process, all Design Submissions shall be anonymous and Submitting Artists shall not be identified. No Submitting Artist identification may be present on any digital image submitted. Failure to comply with these requirements shall render a Design Submission ineligible for the selection process.

- 1. All Design Submissions will be evaluated by a Selection Committee, which could be composed of artists, art professionals, members of the community, and relevant City staff;
- 2. Selection Committee members will review each Design Submission that meets the criteria set out above and herein independently and submit confidential results to the Organizing Committee;
- 3. Where Submitting Artists are submitting multiple Design Submissions, each Design Submission will be assessed separately;
- 4. For the sake of privacy, confidentiality, and to eliminate any real or perceived inferences of bias or influence, the names of Selection Committee members will not be released;
- 5. The selection process may require the short-listing of Design Submissions depending on the number of Design Submissions received by the Selection Committee;
- 6. The Selection Committee will score each Design Submission on a scale of 1 10 (1 being the lowest score and 10 being the highest score) for each of the following criteria:
 - a. First Impression engaging, bold and unique;
 - b. Technique colour, design, technique, etc.;
 - c. Strengthen community identity and place;
 - d. Touches on the Canada 150th Anniversary theme;
 - e. Adaptability to various traffic controller boxes;
 - f. Creativity, Originality, and Uniqueness;
 - g. Use of space; and
 - h. Communication of the piece.
- 7. Scores from each Selection Committee appraisal will be tallied for each Design Submission by members of the Selection Committee;
- 8. A minimum of one (1) and a maximum of three (3) Design Submissions with the highest aggregate scores will be sent to the Organizing Committee for approval;
- Up to three (3) Design Submissions may be chosen by the Selection Committee to be applied to the traffic boxes in the proposed project area (see **Appendix B**) and shall be considered the Successful Design(s);
- 10. If there is more than one (1) Successful Design, the Organizing Committee in consultation with the Selection Committee shall decide the location and number of vinyl wraps for each Successful Design that will be applied to the traffic boxes in the City of Sault Ste. Marie;
- 11. It is possible for a Submitting Artist to have more than one (1) Successful Design in this competition;
- 12. Decisions of the Selection Committee are final and cannot be contested;
- 13. All Submitting Artists shall be advised whether or not their respective Design Submission was the Successful Design. The Successful Artist(s) will be asked to keep the decision confidential until the Successful Design(s) is revealed at Council; and
- 14. Each Successful Artist(s) of the Successful Design(s) shall receive full recognition of their work, wherever possible (i.e. press release, reveal event, etc.). The Successful Artist(s) consents to the public release of their name/identity by The Corporation of the City of Sault Ste. Marie.

APPLICATION CHECKLIST

- 1. Up to three Design Submissions in high resolution digital format (JPEG) with no identification on the images;
- 2. Short descriptive statement;
- 3. Completed application; and
- 4. Signed Acknowledgement and Indemnity.

All Design Submissions must contain <u>all</u> of the above noted requirements to be complete. If a Design Submission fails to include any of the above noted elements, the Design Submission shall be determined to be incomplete and shall not be accepted for entry into the competition.

The City of Sault Ste. Marie is holding a competition for artists' works to be fabricated on a vinyl wrap to be placed on traffic boxes throughout downtown.

This Competition will increase public knowledge and appreciation of our local fine arts. It creates an opportunity that gathers diverse artists together in a high-quality opportunity to showcase their work and represent their City.
